
2019: A YEAR OF ENGAGEMENT


SPPOA Updates

Monthly Joint Labor Management (JLM) notes.

- 1. Probation Field Division: For improved health and wellness, the Association has requested that a couple work stations be opened on a shared-basis with ergonomical stand up desks. Management is in agreement and will move forward with the proposal.
- 2. Probation Field Division: With the recent adult division policy revisions and the rolling out of the new evaluation, the Association has stressed that during the pilot period of the new evaluation process, it be focused on supervisors being efficiently trained and line staff being supported.
- 3. Juvenile Detention Facility: The Association is meeting with management in January 2019 to discuss improving safety and security for our staff.

1. State Coalition of Probation Organizations Legislative Day at the State Capitol is set for Wednesday, March 27, 2019. More details to come.




Collective (adjective):
